

**THE CORPORATION OF THE TOWNSHIP OF DUBREUILVILLE**

**BY-LAW No. 2004-35**

***Being a By-law to regulate the setting off of fireworks within the Township of Dubreuilville.***

WHEREAS the Municipal Act 2001, Section 121, authorizes Councils of local municipalities to prohibit and regulate the sale of fireworks and the setting off of fireworks; and

WHEREAS the Council of The Corporation of the Township of Dubreuilville deems it necessary to pass such a by-law to regulate the setting off of fireworks,

NOWHEREFORE the Council of The Corporation of the Township of Dubreuilville ENACTS AS FOLLOWS:

1. The Fire Chief shall be responsible for administration and enforcement of this by-law.
2. There shall be no setting off of any kind of firework displays within the limits of the Township of Dubreuilville on any day during the year unless a permit has been obtained from the Fire Chief (schedule "A" attached hereto). A fee of five dollars (\$5.00) will be payable for every permit issued.
2. Any person having obtained a permit for the setting off of fireworks shall be an approved competent operator and shall be responsible for the setting off of the said fireworks on the prescribed date and site as approved by the Fire Chief.
4. The Fire Chief may, at any time, require that the Dubreuilville Fire Department supervise any firework display.
5. The Fire Chief may, at any time, revoke a permit for the setting off of fireworks without any reason.
6. Any person who contravenes any of the provisions of this by-law is guilty of an offence and upon conviction is liable to a fine as provided for in the Provincial Offences Act.
8. This By-Law shall come into force and take effect upon its reading and being passed.
9. By-Law No. 99-13 is hereby repealed.
